- Robert Heeder, 28, of Craryville, was arrested at 4:50pm July 17 and charged with Criminal Possession of a Controlled Substance in the Seventh Degree (Class A Misdemeanor), Aggravated Unlicensed Operation of a Motor Vehicle in the Third Degree (Class U Misdemeanor), and uninspected motor vehicle (Traffic Infraction) by Deputy Peter Merante. Heeder was stopped operating an uninspected motor vehicle on State Route 9H in the Town of Kinderhook. He was operating the vehicle with a suspended license and was found in possession of a quantity of LSD. He was issued tickets returnable to Kinderhook Town Court on August 7.
- Jonathan Muniz, 36, of Stottville, was arrested at 2:37am July 18 and charged with Endangering the Welfare of a Child (Class A Misdemeanor) and Harassment in the Second Degree (Violation) by Deputies Ted Blank and David Stevens. Muniz is accused of grabbing and pushing a child. He was arraigned in Stockport Town Court and was ROR with a return date of August 13.
- Miranda Graham, 31, of Hillsdale, was arrested at 2:53am July 17 and charged with Criminal Possession of a Controlled Substance in the Fifth Degree (Class D Felony), Criminal Possession of a Controlled Substance in the Seventh Degree (Class A Misdemeanor), and Unlawful Possession of Marijuana (Violation) by Deputies Zachary Sohotra and Zachary Torchia. Graham was stopped on Main Street in the Village of Philmont. She was found in possession of a quantity of heroin, cocaine, and marijuana. Additionally, Deputies arrested a passenger in the vehicle, 28 year old William Metz of Claverack, and charged him with Criminal Possession of a Controlled Substance in the Fifth Degree (Class D Felony) and Criminal Possession of a Controlled Substance in the Seventh Degree (Class A Misdemeanor). Metz was in possession of a quantity of heroin and cocaine. They were both arraigned in Claverack Town Court and remanded to the Columbia County Jail in lieu of \$500 bail. They will appear in Philmont Village Court at a later date.
- Edward Colwell. 39, of Germantown, was arrested at 3:25am July 15 and charged with DWI (Class U Misdemeanor), fail to keep right, and operating an uninspected motor vehicle (Both Traffic Infractions) by Deputies Joseph Bruno and Thomas Merante. Deputies were dispatched by Columbia County 911 to a one vehicle personal injury accident on State Route 9G in the Town of Livingston. The vehicle left the roadway striking a guard rail, into a ditch and then overturned. Colwell, who was the only occupant in the vehicle, was transported to CMH. Deputies issued him tickets returnable to Livingston Town Court on August 16.
